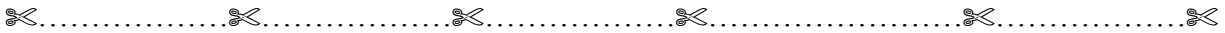




**CHESTNUT HILL'S
